Each shipment or delivery is subject to Geo Solutions approval of Applicant's creditworthiness including, without limitation, a determination that Applicant is not in default upon any obligation to Geo Solutions. Applicant agrees to pay all costs of collection including such reasonable attorneys' fees as may be allowed by law.

## 2. Warranty, Limitation of Warranty and Liability:

Geo Solutions products are warranted to be following stated specifications. THIS WARRANTY IS EXPRESSLY MADE IN LIEU OF ANY OTHER EXPRESSED OR IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS OF PURPOSE AND ANY OTHER OBLIGATION ON THE PART OF GEO SOLUTIONS. GEO SOLUTIONS SHALL NOT BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES, LOSSES OR EXPENSES ARISING IN CONNECTION WITH THE USE OF, OR INABILITY TO USE, ANY GOODS SUPPLIED BY GEO SOLUTIONS.
